

- Help people **progress into work**


This is essential in achieving **an inclusive economy** for all our residents.

- Covid-19 led to an economic shock that has been unprecedented in its size and speed
- The pandemic has made **existing high youth unemployment and high adult worklessness more acute in our region; many of our businesses have been impacted** and a **significant proportion of our residents are reliant on employment in the sectors most affected, such as retail, culture, leisure and tourism**
- The **skills system has a key role to play in supporting our recovery from the crisis as well as meeting our longer term economic and social challenges** such as the UK's withdrawal from the European Union, rapid technological change and population ageing which all demand a prompt and effective response.




Our recovery and growth sectors

NTCA investments are making a positive difference to the lives of many of our residents. We are:


- Investing in **new employability and skills programmes and pilots** that deliver through communities and removing barriers for residents accessing employment, education and training
- **Reshaping the delivery of Adult Education provision** to better equip our residents with the skills needed to access good work and to progress
- Supporting residents to **become digitally connected, removing barriers to participation and equipping residents for the future of learning** and work
- **Supporting skills in our growth and recovery sectors** through our Digital Growth and Innovation Programme and unlocking the potential of a green economy through our Green Skills Fund
- **Prioritising the provision of quality apprenticeships.** This includes an Apprenticeship Hub which provides useful resources, links and signposting and a service to match potential apprentices to apprenticeship vacancies tailored to actual opportunities and growth sectors
- Building on the **NTCA/DWP Framework Agreement with a delivery plan focused on a joined-up approach** to drive the better coordination of employment, skills and health services across the North of Tyne area in order to increase the number of residents moving into work.



A call to action:

- Working together across our constituent local authorities, the North East LEP, employers, colleges, training providers, universities, and the voluntary, community and social enterprise (VSCE) sector, we have made great progress but **there is more to be done**
- We need a **collaborative model of skills provision, with providers and employers working together to make the most of specialist strengths and sharing resources where appropriate**
- **We need to support our employers to recognise their role and responsibility in developing the skills of their current and future workforce.**




